

## INFORMATION FOR AUTHORS

The IEEE TRANSACTIONS ON VERY LARGE SCALE INTEGRATION (VLSI) SYSTEMS includes all major aspects of the design and implementation of VLSI/ULSI and microelectronic systems. Topics of special interest include: systems specifications, design and partitioning, high performance computing and communication systems, neural networks, wafer-scale integration and multichip module systems and their applications. It is published monthly. Contributed papers may be of a tutorial nature. TRANSACTIONS Briefs include contributions of the following nature: corrections; rebuttals of previous briefs; comments on published results; discussion of experiences using published results; conjectures; posing of new problems; announcement of new results and other contributions written in the format of a correspondence. Research papers must contain original contributions and must not duplicate descriptions or derivations available elsewhere. The author should limit paper length whenever this can be done without impairing quality.

If a contribution is of sufficient general interest to the entire IEEE membership, it will be recommended for publication in the PROCEEDINGS OF THE IEEE. Submission of a manuscript manifests the fact that it has been neither copyrighted, published, nor submitted for publication elsewhere, unless otherwise so stated by the author.

To avoid delay, please be guided by the following suggestions.

### A. Process for Submission of a Technical Paper

- 1) Submit electronic version of your manuscript to (<http://mc.manuscriptcentral.com/tvlsi-ieee>). The manuscript should be complete with references, illustrations, abstract, and index terms.
- 2) If the manuscript has been presented, published, or submitted for publication elsewhere, please so inform the Editor-in-Chief. Our primary objective is to publish technical material not available elsewhere, but on occasion we publish papers of unusual merit that have appeared or will appear before other audiences.

### B. Style for Submission of Manuscript

- 1) Each manuscript must be formatted using the IEEE two-column format from the initial submission. Style templates can be found at: <http://www.ieee.org/pubs/authors.html>.
- 2) The **maximum length** of each manuscript is **14** pages for a regular paper and **5** pages for a brief including **references, figures, tables, equations and biographies**. Submitted papers that are **not compliant** with either the allowed page lengths or the style format **will be returned to the authors**. The biographies and photographs of the authors must be added at the time of submission, so that a good estimate of paper length can be obtained.
- 3) Each manuscript should be complete with illustrations (if any), abstract, and at least 5 keywords. The abstract must be a concise yet comprehensive reflection of what is in the article. In particular:
  - The abstract must be self-contained, without abbreviations, footnotes, or references. It should be a microcosm of the full article.
  - The abstract must be between 100-250 words. Be sure to adhere to these limits; otherwise, it must be edited accordingly.
  - The abstract must be written as one paragraph, and should not contain displayed mathematical equations or tabular material.
  - The abstract should include three or four different keywords or phrases, as this will help readers to find it. It is important to avoid over-repetition of such phrases as this can result in a page being rejected by search engines.
  - Ensure that the abstract reads well and is grammatically correct.
  - Graphical abstracts can be displayed along with traditional text in IEEE Xplore. Please visit [http://www.ieee.org/publications\\_standards/publications/graphical\\_abstract.pdf](http://www.ieee.org/publications_standards/publications/graphical_abstract.pdf) for more information.
- 4) Each manuscript should contain in the first page the full names and (typically as footnotes) affiliation of all authors, as well as their email addresses. Acknowledgement of financial support is often placed at the end of the footnote.
- 5) References should appear in a separate bibliography section at the end of the paper, with items referred to by numerals in square brackets, e.g., [12]. In either case, references should be complete and in IEEE style.

*Style for papers:* Author, first initials followed by last name, title, volume, inclusive page numbers, month, and year.

*Style for books:* Author, title, location and publisher, year, chapter or page numbers (if desired).

*Important:* If part of the manuscript has been presented, published or submitted elsewhere, this should be noted in the submission form that the author will access before uploading their manuscript at <https://mc.manuscriptcentral.com/tvlsi-ieee>. In particular, authors must explain major differences between the prior work(s) and the manuscript submitted to this Transactions. This must be attached right after the bio section.

### C. Style for Illustrations

- 1) Illustrations should be sharp, noise-free, and of good contrast. We regret we cannot provide drafting or art service.
- 2) On graphs, show only the coordinate axes, or at most the major grid lines, to avoid a dense hard-to-read result.
- 3) All lettering should be large enough to permit legible reduction of the figure to column width, perhaps as much as 4:1. Typing on figures is not acceptable.

### D. Final Manuscripts Electronic Submission Process

If a manuscript is accepted for publication, the author will:

- 1) Log into the Author Center on Manuscript Central and submit the final manuscript.
- 2) Click on "Awaiting Final Files" and follow the submission process. Make sure the files are complete as you will not be able to modify the submission in Manuscript Central.

### E. Open Access

This publication is a hybrid journal, allowing either Traditional manuscript submission or Open Access (author-pays OA) manuscript submission. Upon submission, if you choose to have your manuscript be an Open Access article, you commit to pay the discounted \$1,750 OA fee if your manuscript is accepted for publication in order to enable unrestricted public access. Any other application charges (such as over-length page charge and/or charge for the use of color in the print format) will be billed separately once the manuscript formatting is complete but prior to the publication. If you would like your manuscript to be a Traditional submission, your article will be available to qualified subscribers and purchasers via IEEE Xplore. No OA payment is required for Traditional submission.

### F. Page Charges

After a manuscript has been accepted for publication, the author's company or institution will be approached with a request to pay a charge of \$110 per page. Payment of page charges for this IEEE TRANSACTIONS is not obligatory; nor is it a prerequisite for publication. The author will receive 100 reprints (without covers) free only if the page charge is honored. If this charge is not honored, IEEE will charge a mandatory page charge of \$200 per page in excess of nine (9) pages (maximum of 14 pages) for Regular Papers, or in excess of four (4) pages for TRANSACTIONS Briefs. In no case may a TRANSACTIONS Brief exceed 5 pages.

### G. Copyright

It is the policy of the IEEE to own the copyright to the technical contributions it publishes on behalf of the interests of the IEEE, its authors, and their employers, and to facilitate the appropriate reuse of this material by others. To comply with the U.S. Copyright Law, authors are required to sign an IEEE copyright transfer form (<http://www.ieee.org/web/publications/rights/index.html>) before publication. This form returns to authors and their employers full rights to reuse their material for their purposes. Authors must submit a signed copy of this form with their manuscript.
